(INTERVIEW) INTERVIEW OF FINDER OF BODY.

Summary of Investigation:

- 1. On December 31, 2009, at approximately 1230 hrs the undersigned interviewed the above named witness in her father's apartment located at 155 W 68 Street apt 510. This witness is the nine year old daughter of the deceased and is the finder of her mothers body.
- Despite this witness' young age the circumstances regarding her mother's death have necessitated interviewing the child. The child was able to supply the following information.
- Anna states that last night she and her three year old brother Myles had been at their father's apartment across the hall from their mother's apartment where they live until about eight PM. After returning to their mothers apartment she and her brother were hungry. They both ate apples and some tea biscuits and then got ready for bed.
- 4. Both children got into their mothers bed and Anna read a story to Myles. The children then began to go to sleep. Anna states that while she and her brother were going to sleep she heard her mother in the bathroom running the water into the tub for a bath. She was sure, she said, because when the tub is filling the water sounds different from when the shower is running. While their mother is in the tub the children go to sleep.
- 5. Both children wake up at about two or three in the morning and realized that their Mom was not in bed with them. They both get out of bed and Anna goes to the bathroom door and looks in. She sees her mother still in the tub and her Mom is sort of kneeling but her face is in the water. Anna thought that her mother was washing her hair and pushed her brother back into bed. The children both get back into the bed and go back to sleep.
- 6. Anna woke up at approximately 7:00 AM. Again she realizes that her Mother is no in bed with her and her brother. She get up and goes to the bathroom door and looks in. She sees that her mother is still in the bath tub and her face is still under water. She gets very afraid realizing that something is wrong with her mother and so she goes to the phone and calls her father who lives across the hall. Her father instructs her to go and open the front door to the apartment and let him in. Anna does this. Her father goes to the bathroom and sees Shele and then ushers the kids into Anna's room instructing them to stay there. He then called the police.
- 7. In response to questions Anna stated that she did not hear any loud noises coming from anywhere in the apartment during the night. She added that both she and her brother are very sound sleepers.
